Objectives of the scheme

- Facilitate access to quality education with an aim to equip youth with knowledge, skills, experience and training for higher academic level/ profession.
- To build capacities of youth of Jammu & Kashmir and Ladakh by educating , enabling and empowering them to compete at national level.
- To provide the youth of Jammu & Kashmir and Ladakh, an exposure to the culture, language and livelihood of other States and union Territories to promote national integration.



Brief of the scheme

- The scheme is to provide academic fee, maintenance allowance (for bearing expenses on Hostel, Mess, Books, etc.) to students belonging to Jammu & Kashmir and Ladakh, who after passing class XII or equivalent examination, secure admission in Govt. colleges / institutions and other select institution of repute having NBA, NAAC, NIRF ranking and others Centers of Excellence outside the UTs.
- Admission on merit basis through centralized counseling conducted by AICTE.
- Dental Council of India has allowed (maximum 5(five) seats per institution in BDS under SSS J&K and Ladakh on merit basis. Please visit AICTE website for detailed letter issued by Dental Council of India to all the Dental Institutions in this regard.
- Students who qualify national level entrance examination conducted by Central/ State Governments like NEET, JEE, CLAT etc. are also eligible for scholarship, subject to their registration on AICTE Portal.
- From Academic session 2023-24, B.A(LLB) will be considered under professional stream course in National Law Universities(INLU) only.

- ✓ Uploading of Joining Documents by the Candidate
- ✓ Document Verification by Institute and uploading of Joining Report.

Pre-requisites for Registration under SSS JK&L



- Resident of UTs of J&K or Ladakh (Domicile Certificate)
- Passed 10+2 from JKBOSE/CBSE(enrolled in 2021 and passed in 2022 or enrolled in 2022 and passed/appearing in 2023) (Roll Number/Year of Passing is required) from the schools of Jammu & Kashmir or Ladakh only
- Passed 10+3 Diploma from JKSBOTE (Passed/Appearing in academic year 2022 or 2023)
- Family Income is upto Rs. 8.00 Lakhs (**Family Income Certificate issued by Govt. J&K or Ladakh – not more than 6 months old**)
- Reservation Policy as per the norms decided by the J&K Govt.
- Active Aadhaar Number – seeded with saving Bank Account of the student will only be accepted
- **Valid Mobile Number & Email ID for future communication (Important)**
- Candidate, Mother & Father Name exactly as per Matric Certificate

STUDENT IS ELIGIBLE, IF

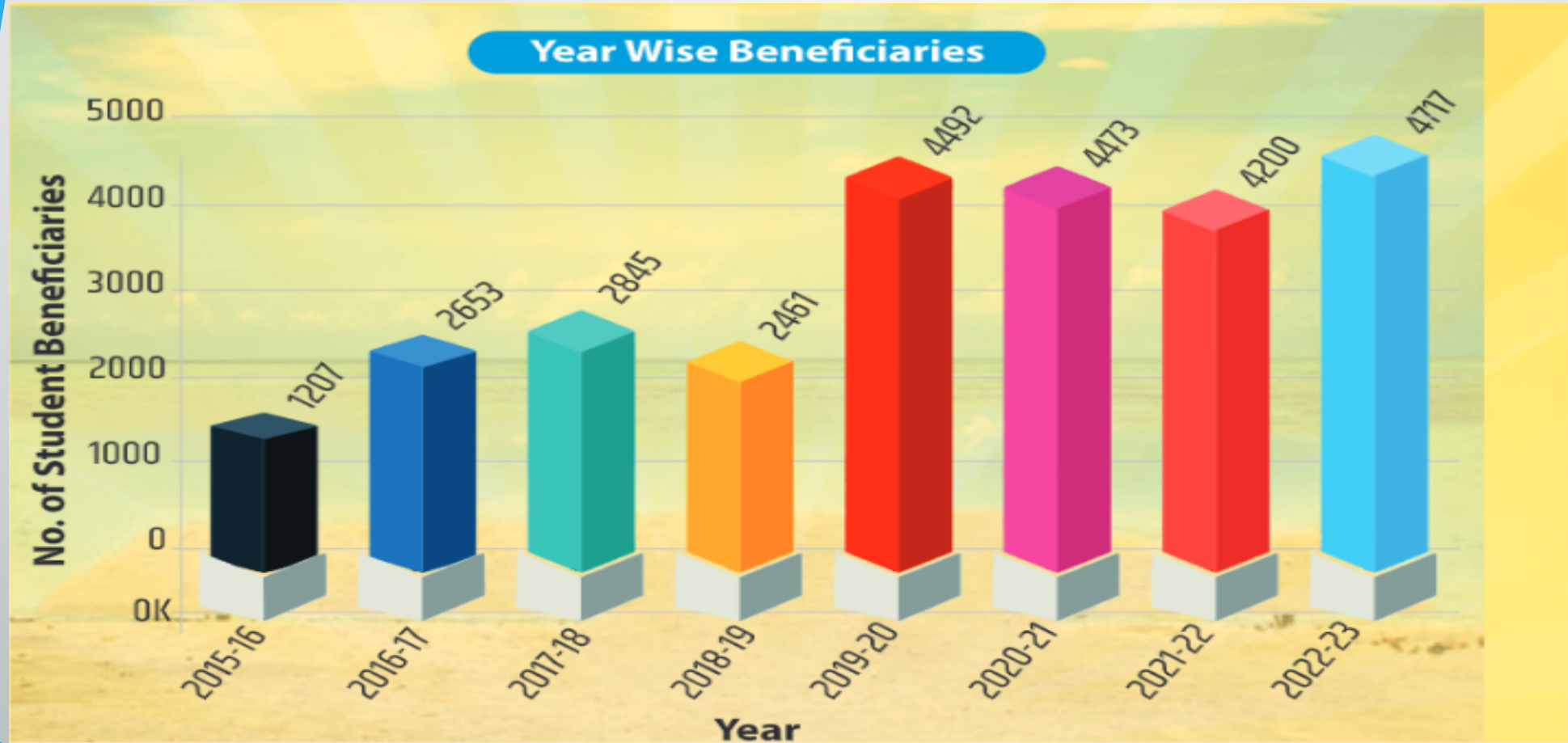
- Domicile of Union Territories of UTs of J&K and Ladakh.
- Passed 10+2 Exam from JKBOSE or CBSE affiliated schools located in Union Territories of J&K and Ladakh
- Passed 10+3 Diploma from Union Territories of J&K and Ladakh Polytechnic for admission directly in second year. Registration/ Counselling will be conducted subject to the vacancy in previous academic year in prescribed list of Institutions.
- Fulfill minimum age and other eligibility criteria as prescribed by the Institution / University.
- Family income not exceeding Rs. 8.00 Lakh per annum



STUDENT IS NOT ELIGIBLE, IF

- Not applied through online registration on AICTE Portal
- Course is offered by an Open University
- Availing benefits from other Govt./Non-Govt. Scheme including scholarships from National Scholarship Portal
- Admission to the course is through Management Quota
- Joined Institution other than those in AICTE Portal
- Pursuing any Diploma / Post Graduate Programme
- Admission is through Agents / NGOs.
- Absent during the counseling
- Taken admission in other than allotted college

Advisory For Students

- ❖ Must maintain a no frill bank account
- ❖ Aadhaar / Bank Account seeding must be done when registering.
- ❖ Check mandatory requirements of colleges / courses for Urdu language / medium of instructions etc.
- ❖ Check the reservation policy of the J&K Govt. carefully before filling the caste category in the form.
- ❖ Check availability of hostel (Not all the colleges have hostel facilities).
- ❖ Women colleges (male candidates are not eligible)
- ❖ Check the minimum age criterion
- ❖ Connect with students of previous year
- ❖ Students have to abide by all the rules and regulations of College/University. AICTE does not intervene in the matter.
- ❖ Not to share user name and password with any body
- ❖ Correspond with AICTE only using email/phone /candidate ID registered on the portal.
- ❖ Students leaving the course / college in between will have to refund the scholarship amount otherwise they will be debarred for admission next year. This will be informed to National Scholarship Portal also.
