While talking with the students, it came to foref that on the day of 30th July 2022, the victim student namely, Rumaisa Nabi (BG 3rd Semester, Batch-20 has attended the class scheduled at 10:00 am in the room no. 07, Arts Block, after which she went to college conference hall with her other batchmates viz. Bazila, Suraya etc., where she has argued participation in the ongoing event with the organizer. While talking with the organizer of the event, it can limelight that on prima facie basis it seemed that the said student was not feeling well as she spoke in irrele manner on the reported day. Thereafter, the said student has been seen seated in-front of Old Block t Chinar Tree, wherefrom she countered one of the college professor again in irrelevant manner, who requested the female staff members around there (namely Ms. Ulfat and others) to interact with the girl at the needful. Subsequently the ladies faculty accompanied the girl towards the college main gate so that student reaches home safely, as it was established that the residence of said students is falling outside the g
- The committee later took a separate interaction with those students who are friends of the complainant. the interaction, it was established that the said girl was disturbed since entering the college campus c given day. After further, investigation it was also revealed that the girl had some affair with a boy na Irfan, (who has cancelled his admission from the college, therefore, is no more on college rolls), which sh shared with the college friends.
- · After all the interactions carried out during the investigation on the given matter, no where ascertained/observed that the girl has taken or forced to take any abused medicine or the girl was harass the day of 30th July 2022 in the college campus.
- · Hence, the committee is of the opinion that nothing wrong has been done or happened with the said girl college campus on the day of 30th July 2022. Therefore, the same is submitted for further necessary thereof (if any).

ROLE AND RESPONSIBILITY OF ANTI-SEXUAL HARASSMENT COMMITTEE

- 1. To ensure provision of a work and educational environment that is free from any act of sexual harassment.
- 2. To take all reasonable steps (active and preventive in nature) to prevent the harassment occurring; To address any oral/written complaint about: unwelcome sexual advances, unsolicited acts of physical intimacy, unwelcome requests for sexual favors or other unwelcome conduct of asexual nature. Unwelcome conduct of a sexual nature includes oral or written statements of a sexual nature to a person, or in a person's presence.
- 3. Obtain support from the Principal for implementing a comprehensive strategy: Providing information to all staff and students about what constitutes sexual harassment and about their responsibility not to sexually harass other staff and
- 4. Develop a written policy which prohibits sexual harassment. The Institution shall have a Sexual Harassment Policy. The policy outlines the Institute's key commitments and legal responsibilities and provides a definition of sexual harassment and behaviors that are not acceptable.
- 5. Regularly distribute and promote the policy at all levels of the institution; Periodically review the policy to ensure it is operating effectively and contains up to date information.
- 6. Display anti-sexual harassment posters on notice boards in common work areas and distribute relevant brochures; Conduct regular awareness raising sessions for all staff/students on sexual harassment issues.
- Ensure that complaints processes:
 - are clearly documented;
 - are explained to all employees;
 - · offer both informal and formal options for resolution;
 - address complaints in a manner which is fair, timely and confidential;
 - are based on the principles of natural justice;
 - provide clear guidance on internal investigation procedures and record keeping;
 - Give an undertaking that no employee will be victimized or disadvantaged for making a complaint.

POWERS OF THE COMMITTEE

- 1. The Committee shall have the power to summon witnesses and call for documents or any information from any employee/student.
- 2. If the Committee has reason to believe that an employee/student is capable of furnishing relevant documents or information, it may direct such person to produce such documents or information by serving a notice in writing on that person, summoning the person, or calling for such documents or information at such place and within such time as may be specified in the written notice.
- 3. Where any relevant document or information is recorded or stored by means of a mechanical, electronic or other device, the Committee shall have the power to direct that the same be produced, or that a clear reproduction in writing of the same be
- 4. Upon production of documents / information called for by it, the Committee shall have the power to (i) make copies of such documents / information or extracts there from; or (ii) retain such documents / information for such period as may be deemed necessary for purposes of the proceedings before it.
- 5. The Committee shall have the power to issue interim directions to / with regard to any person participating in the proceedings before it.
- 6. The Committee shall have the power to recommend the action to be taken against any person found guilty of:
 - a) sexually harassing the complainant.
 - b) retaliating against / victimizing the complainant or any other person before it; and
 - c) making false charges of sexual harassment against the accused person.

FUNCTIONS OF THE COMMITTEE PREVENTIVE STEPS.

a) To facilitate a safe environment that is free of any act of sexual harassment;

b) To promote behaviours that create an atmosphere that ensures gender equality and equal opportunities.



PROCEDURE TO BE FOLLOWED BY THE COMMITTEE

- 1) The Committee shall meet as and when any complaint is received by it. Complaint may be received by any member of the committee.
- 2) The Committee may direct the complainant to prepare and submit a detailed statement of incidents if the written complaint lacks exactness and required particulars, within a period of two (2) days from such direction or such other time period that the
- 3) The Committee shall direct the accused to prepare and submit a written response to the complaint / allegations within a period of four (4) days from such direction or
- such other time period as the Committee may decide. 4) Each party shall be provided with a copy of the written statement(s) submitted by the
- 5) The Committee shall conduct the proceedings in accordance with the principles of natural justice. It shall allow both parties reasonable opportunity of presenting their case. However, should the accused choose not to participate in the proceedings, the
- 6) The Committee shall allow both parties to produce relevant documents and witnesses to support their case. Documents produced by either party shall be affixed with that party's signature to certify the document as original / true copy.
- 7) The party against whom the document / witness is produced shall be entitled to
- 8) The Committee shall sit on a day-to-day basis to record and consider the evidence
- 9) As far as practicable, all proceedings of the Committee shall take place in the
- 10) Minutes of all proceedings of the Committee shall be prepared and duly signed by the
- 11) The Committee shall make all endeavour to complete its proceedings within a period of fifteen (15) days from the date of receipt of complaint.
- 12) The Committee shall record its findings in writing supported with reasons and shall forward the same with its recommendations, to the Principal within a period of five (5) days from completion of the proceedings before it. In case the Committee finds that the facts disclose the commission of a criminal offence by the accused person, this shall be specifically mentioned in the Committee's report.
- If, in the course of the proceedings before it, the Committee is satisfied that a prima facie case of sexual harassment is made out against the accused employee(s)/student and that there is any chance of the recurrence of any such action, or that it is required to do so in the interests of justice, it may, on the request of the complainant or otherwise, disciplinary action could be initiated in the form of:

DISCIPLINE | ANTI-RAGGING

UGC's Rules & Regulations for Prevention and prohibition of Ragging in Educational **Institutes**

The Hon'ble Supreme Court has, inter-alia, mentioned the following types of ragging:-

- 1. Ragging has several aspects with, among others, psychological, social, political, economic, cultural, and academic dimensions.
- 2. Any act that prevents, disrupts or disturbs the regular academic activity of a student should be considered within the academics related aspect of ragging; similarly, exploiting the services of a junior student for completing the academic tasks assigned to an individual or a group of seniors is also an aspect of academics related ragging prevalent in many institutions.
- 3. Any act of financial extortion or forceful expenditure burden put on a junior student by senior students should be considered an aspect of ragging for ragging economic dimensions.
- 4. Any act of physical abuse including all variants of it: sexual abuse, homosexual assaults, stripping, forcing obscene and lewd acts, gestured, causing bodily harm or any other danger to health or person can be put in the category of ragging with criminal dimensions.
- 5. Any act or abuse by spoken words, emails, snail-mails, blogs, public insults should be considered within the psychological aspects of ragging. This aspect would also include deriving perverted pleasure, vicarious or sadistic thrill from actively or passively participating in the discomfiture to others; the absence of preparing 'freshers' in the run up to their admission to higher education and life in hostels also can be ascribed as a psychological aspect of ragging - coping skills in interaction with seniors or strangers can be imparted by parents as well. Any act that affects the mental health and self- confidence of students also can be described in terms of the psychological aspects of ragging.
- 6. The human rights perspective of ragging involves the injury caused to the fundamental right to human dignity through humiliation heaped on junior students by seniors; often resulting in the extreme step of suicide by the victims.

Actions to be taken against students for indulging and abetting in Ragging in institutions

- 1. The punishment to be met out to the persons indulged in ragging has to be exemplary and iustifiably harsh to act as a deterrent against recurrence of such incidents. The students who are found to be indulged in ragging should be debarred from taking admission in any institution in India.
- 2. Every single incident of ragging a First Information Report (FIR) must be filed without exception by the institutional authorities with the local police authorities.

- 3. Depending upon the nature and gravity of the offence as established by the Anti-Ragging Committee of the institution, the possible punishments for those found guilty of ragging at the institution level shall be any one or any combination of the following.
- (i) Cancellation of admission
- (ii) Suspension from attending classes
- (iii) Withholding/withdrawing scholarship/fellowship and other benefits
- (iv) Debarring from appearing in practical/tutorials
- (v) Withholding results
- (vi) Debarring from representing the institution in any regional, national or international meet,tournament, youth festival, etc.
- (vii) Expulsion from the institution and consequent debarring from admission to any other
- (viii) Fine of Rupees 5,000/-
- (xi) Collective punishment: when the persons committing or abetting the crime of ragging are not identified, the institution shall resort to collective punishment as a deterrent to ensure community pressure on the potential raggers.
- 4. The institutional authority shall intimate the incidents of ragging occurred in their premises along with actions taken to the Council immediately after occurrence of such incident and inform the status of the case from time to time.
- 5. Courts should make an effort to ensure that cases involving ragging are taken up on priority basis to send the correct message that ragging is not only to be discouraged but also to be dealt with sternness.

Purpose of Anti-ragging Committee:

The Anti-Ragging Committee must ensure compliance with the provisions of these regulations as well as the provisions of any law for the time being in force concerning ragging; and has to monitor and oversee the performance of the Anti-Ragging Squad in preventing the ragging incidents in the college.

The Committee shall also recommend preventive measures that can be adopted by the college to prohibit, prevent and eliminate the menace of ragging in any form on the campus of the college.

Moreover, according to UGC guidelines, every Faculty shall constitute a smaller body known as the Anti-Ragging Squad to be headed by the Dean of the Faculty with representation as may be considered necessary for maintaining vigil, oversight and patrolling functions and shall remain mobile, alert and active all the time.
