

In this Constitution, unless the context otherwise requires -"Degree College means Government Degree College Kulgam (J&K), an affiliated College of the University of Kashmir.


**ARTICLE 01:**



- c) Any Associate member who has been a member of the alumni association of the college for a continuous period of three years.





**ARTICLE 05: (OFFICE BEARERS AND EXECUTIVE BODY)**

The office bearers of the Association shall be the following:


1. a) The President, b) Vice President, c) Secretary General, d) Secretary, e) Joint Secretary, f) Treasurer, and g) two members.
2. The responsibility for the management of the affairs of the Association and powers necessary to discharge such responsibility is vested in the Executive body. The powers of the Executive body shall include the powers to pass bylaws in addition to those presently in force. The Executive body of the Association shall consist of the following persons:

3. The Office-bearers of the General Body and Executive Body shall be elected at an Annual General meeting and shall hold office for a period of three years. The office bearers and executive members shall be eligible for re-election.
4. The executive body shall meet at least twice a year. The quorum of the meeting of an Executive body shall be one third of its total membership.


**ARTICLE 06:**

**ARTICLE 07:**

**ALUMNI CLUBS, REGIONAL CHAPTERS-ALUMNI ASSOCIATION**

1. Alumni Clubs, regional chapters - alumni association may be formed with the concurrence of executive body, as provided for in the bylaws under this constitution.
2. 2 All activities of same may be coordinated by the association and all annual reports should be submitted by its chairman or the secretaries to the association for further consideration.
3. 3. 25 % of the membership fee collected by any alumni club/regional chapters alumni association shall be remitted to the account of the association.

**ARTICLE 08:**

**MEETINGS OF THE ASSOCIATION**


1. The Annual General Meeting shall be held every year before the end of March, at a time and place determined by the Executive Body.
2. 2 A special meeting can be convened by the Secretary General at the request not less than fifty percent members of Executive Body.
3. 3 The quorum for both the above said meetings shall be 1/10" of the full members, so no decision shall be declared invalid on grounds of any vacancy thereof.

**ARTICLE 09:**

2. All funds of the Association shall be credited to the Bank Accounts of the association, as the Executive committee may deem necessary from time to time.
3. All kinds of payments or indebtedness issued in the name of Association shall be signed by Treasurer and Secretary General, for the same a written receipt shall be issued by the Treasurer. However, donations shall be minuted at the next Executive Body meeting.
4. A special fund to be known as the Alumni Association Endowment Fund shall be created and maintained by the Association.
  - a) All pecuniary or monetary gifts made to the Association.
  - b) Such other funds as the Executive Body may from time to time direct, shall be deposited in the Endowment Fund.Any withdrawals from the Endowment fund shall be at the sole discretion of the Executive Body of the Association.
5. Expenditure from sources other than Endowment fund may be made by the Executive Body.

**FISCAL YEAR AND AUDITING PROCEDURE**


1. The fiscal year of the Association shall be from the 1<sup>st</sup> of April to 31<sup>st</sup> of March.




2. The Seal of the Association shall not be affixed to any document except by the Secretary General, in presence of the President or Vice President.
3. The custodian of the Seal shall be Secretary General.


**ARTICLE 12:**

**BY-LAWS OF THE ASSOCIATION.**

1. The President shall exercise the powers normally due to that position. He or she shall have the right to reinterpret any procedural question arising out of clarification. He/she shall preside at all meetings of the association and of the Executive Meetings, in his absence the same meeting will be presided by the vice president.
2. The Vice-President shall assume the duties designated to him and shall have particular responsibility of the functions of one of the standing committees of the Association.
3. The Secretary General shall be responsible for:-
  - a) Issuing of notices for the Annual General meeting, Special General meetings of the Executive Body.
  - b) the preparation, circulation, presentation and maintenance of the minutes and records of all meetings,
  - c) The circulation of the agenda not less than seven days prior to such a meeting and or minutes of meetings,
  - d) The maintenance of the membership registers of the Association.
  - e) The Secretary General shall convene a special meeting of the Association at the written request of not less than one third of members of the executive body.
  - f) The Secretary General shall prepare and present an annual Report of the activities and programmes of the Association at the Annual General meeting,
4. The Treasurer shall assist the Executive body referred to in Article (v) in financial planning and expenditure. He/ she shall be responsible for the maintenance of the proper accounts of the association. He /She shall also prepare and present an annual statement of audited accounts at the annual general meeting.
5. The committee on College Development shall from time to time formulate shortterm and long-term proposals for the development of the college. The committee may suggest ways and means of obtaining financial assistance and getting cooperation to implement such proposals,

6. The committee on Student welfare shall promote relations between the alumni and the students of the college. It shall, from time to time, enquire into and report on student welfare services within the college and formulate proposals for their improvement. The committee shall also be responsible for effective links between prospective employers and college students and graduates.
7. The committee on Finance shall formulate budget in advance.
8. The committee on Public Relations and Alumni welfare shall promote better relations between the college, the Association and the community, through publications, meetings, seminars, workshops, discussions and through mass media. The committee shall formulate proposals for the welfare of the Alumni and conduct activities to enroll new members.
9. The committee on Continuing Education & Extension Education shall act as a consultative committee to the college. The committee shall organise and conduct courses, Extension programme workshops, seminars etc.
10. The committee on Alumni Clubs and Reunions shall promote and elevate the effectiveness of the alumni clubs, and may make recommendations for their improvement. The committee shall also formulate and submit programme for reunion and other related matters.
11. The committee on Elections and Constitutional Matters shall be in charge of recommending proceedings for the conducting of elections and shall advice on the interpretation, modification or amendment of the constitution and of the by-laws. It shall also recommend any constitutional and procedural matters, when so requested and report to the special/general meeting.
12. The registration fee a) for members (excluding on roll students) shall be Rs.300/. b) for on roll students shall be Rs. 100/-
13. The number of Honorary members shall not exceed filty. The first election ot the executive members of the association shall be held at the inaugural meeting of the association and nomination to all he posts shall be accepted at the meeting.

**PROCEDURE FOR ELECTING EXECUTIVE MEMBERS**

3. In case of vacancy/ies during the course of the year, such vacancy/ies shall be filled by the executive committee within one month or at general meeting whichever is earlier

**ARTICLE 13:**

**AMENDMENTS**

Any amendment to the above-mentioned guidelines shall require an approval of at least two-third of the full membership present at the Annual General Meeting /Special Meeting but the proposed amendment draft shall be given to each member prior to at least one week.

**DISPUTES**


The Executive Body shall appoint a lawyer that shall handle disputes and legal issues, if any, involving the Association.


**ARTICLE 15**
